

**Minor Child Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement
("Agreement")**

My name is _____ and I am the parent and/or legal guardian of _____,
(Name of parent/guardian) (Name of child)

a minor child ("minor" or "the minor"). In consideration of the Boston Red Sox Baseball Club allowing the minor to participate in baseball activities and/or activities relating to the game of baseball on the field at Fenway Park (the "Activities"), I am agreeing to the terms of this Agreement, including the general waiver and release of liability described below.

I fully understand that there are risks relating to the minor's participation in or observation of the Activities including the risk of serious bodily injuries and property damage, which injuries and damage could arise out of his or her own actions or inactions, those of others participating in the activities, the weather or other conditions in which the Activities takes place, his or her health conditions, equipment used in connection with the Activities, or the negligence of the Released Parties named below. I also fully understand that all risks are not apparent, knowable or foreseeable. I hereby knowingly and voluntarily assume all risks relating to the Activities, including the risks of serious bodily injuries such as permanent disability, paralysis or death, and agree to be responsible for any and all injuries, damages, costs, expenses and other losses that could arise at any time as a direct or indirect result of the minor's participation in or observation of the Activities. I acknowledge that the Boston Red Sox Baseball Club will be responsible for supervising the minor or any other individuals participating in the Activities. It will be my responsibility to discontinue the minor's participation in the Activities if I believe that any circumstances relating to the Activities are unsafe or that his or her participation in or observation of the Activities will result in harm to the minor.

I promise and agree that I will not file a suit, pursue any claim, or seek to hold the Boston Red Sox Baseball Club and its respective owners, affiliates, stockholders, partners and advertising or promotional sponsors, or any of their officers, employees, representatives, volunteers and agents or any one of them (collectively, the "Released Parties") liable or responsible for any costs, damages or losses of any kind in the event the minor is injured or his or her property is damaged in connection with the Activities, whether or not the damage or injury is due in whole or in part to the negligence of any of the Released Parties. I also agree that if anyone makes a claim on my behalf, or on behalf of the minor against any of the Released Parties, I will indemnify, defend and hold the Released Parties harmless from and against any and all such claims at my own cost.

If I breach my obligations under this Agreement, I will be responsible for reimbursing the Released Parties for all costs incurred by the Released Parties to defend itself against any and all claims that result from such breach.

I consent to the Boston Red Sox Baseball Club using and authorizing others to use the minor's name and/or photograph or other likeness for promotional and advertising purposes without compensation to me, the minor or my or the minor's heirs.

I have read this AGREEMENT AND UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS BY SIGNING IT, INCLUDING THE RIGHT TO DEMAND ANY COMPENSATION FOR ANY INJURY OR DAMAGE THAT MAY OCCUR AS A RESULT OF THE ACTIVITIES. I am signing this Agreement and agreeing to its terms freely and without any inducement of any nature. I agree that if any portion of this Agreement is held to be invalid, all other terms shall continue in full force and effect.
